General Course Information

Q: What is the duration of each course? Once I sign up, do I need to take the entire course immediately?

Once you sign up for an OCHIN AAPC-certified medical billing/coding course and pay the associated course fee, you obtain access to our virtual course content for a period of 12 consecutive months. You can complete the course at your own pace, any time before this 12-month interval expires. Many busy professionals find this flexible, on-demand approach particularly advantageous. Other students prefer to take the entire course immediately, in which case the following course durations generally apply:

Our courses are segmented into individual **units**, with each unit equating to one full week of course content. It generally takes 10-20 hours of study time to complete each unit. The course durations indicated above are therefore estimates, but please contact us at ochinpluslearning@ochin.org for additional insights and specific course unit topics.

Q: Am I guaranteed job placement after completing my chosen OCHIN+ course(s)?

Completion of our AAPC-certified medical billing and coding courses does *not* guarantee employment within the health care industry, or at any of OCHIN's member organizations. However, students who successfully pass a final exam *do* earn AAPC certification in their area(s) of specialization (billing, coding, or both). This is a highly respected industry designation that prospective employers notice and value. The certification itself can help expand a student's professional network and open new doors to potential employment. This is particularly true when it's combined with optional paid or unpaid externship opportunities, where available. Please see the separate "externship" section for details.

Q: Do I earn automatic AAPC certification just by taking one of your OCHIN+ billing/coding courses?

No. You must take and pass a special exam at the end of each course to earn actual AAPC certification as a medical billing or coding professional. These exams align to your chosen topic of study and are administered as part of each respective course. Your course fee includes all necessary materials to support your success.

Q: Do these courses provide internship and/or externship opportunities—and are either of these actually required to complete any of the courses?

Our AAPC-certified medical billing and coding courses currently provide *externship* opportunities that help students continue to learn about advancing health equity. These paid or unpaid externships place students at an OCHIN member site to gain real-life experience in a health clinic setting as part of the OCHIN+ program. All OCHIN member health centers serve diverse communities and are dedicated to providing quality, just, affordable care. While completing an externship is not formally required to complete a given course or become certified, it is considered an industry best practice that provides valuable experience. Interested students may also apply to explore pathways for paid *internships* within OCHIN as they become available.

Q: What are the hardware requirements for your AAPC-certified medical billing and coding courses?

These courses can be taken on a PC, Mac, or Chromebook.

Q: What are the software requirements for your AAPC-certified medical billing and coding courses?

All necessary software must be installed and fully operational before students can begin their coursework. Students must also have email capabilities, including access to a personal email account.

- **PC:** Windows 8 or later
- **Mac:** macOS 10.6 or later
- **Browser:** Latest version of Google Chrome or Mozilla Firefox preferred; Microsoft Edge also compatible
- **Word processing software:** Microsoft Word or equivalent (not included with enrollment)
- **PDF management software:** Adobe Acrobat Reader

Q: What are the instructional material requirements for your AAPC-certified medical billing and coding courses?

All instructional materials required for these courses are included in enrollment. Textbooks, workbooks, and codebooks will ship to students approximately seven to 10 business days after enrollment.

Medical Coding Certification

Q: What are specific requirements to earn and maintain an AAPC medical coding (CPC) certification?

Students wishing to earn and maintain an AAPC medical coding certification must:

- **Maintain a yearly AAPC membership.** You must become an AAPC member *prior* to scheduling your CPC exam. Renewing professionals must have a current membership at the time of exam application, or when exam results are released.

- **Substantiate two years' worth of medical coding experience.** Full CPC designation requires two years or the equivalent of medical coding experience. Individuals who do not submit such proof can earn a CPC-A (apprenticeship) designation.
- **Complete 36 continuing education units (CEUs).** Once certified, this continuing education requirement applies every two years.

Q: For those pursuing *medical coding* certification, what is a CPC-A designation?

Passing your initial CPC exam results in a CPC-A credential, with the “A” signifying *apprenticeship*. This apprenticeship standing is maintained until your two-year experience requirement is satisfied. Once you can submit proof of meeting this two-year requirement, the “A” is removed from your CPC certification. Here are various ways to work toward and fulfill this two-year requirement:

1. **Demonstrate two years of on-the-job experience using CPT®, ICD-10-CM, or HCPCS Level II code sets.**
 - Obtain and submit two letters of recommendation substantiating the above.
 - One letter must be from your employer on company letterhead.
 - The second letter may come from a colleague or a previous employer.
 - Experience coding for a previous employer *prior to certification* also counts toward this two-year requirement.
 - You can also earn one year of on-the-job experience as outlined above and combine this with one of the measures noted below.
2. **Complete at least 80 contact hours of a coding preparation course, which equates to one year of coding experience.**
 - Submit a letter from an instructor on school letterhead, a certificate/diploma, or an unofficial school transcript substantiating the above.
3. **Complete the CPC-A Practicode online curriculum, which equates to one year of coding experience.**
 - This online program is comprised of three modules, each containing 200 cases.
 - The program may be completed while training for your certification exam or afterward.

To satisfy the two-year requirement, Option 1 may suffice alone. Alternatively, Option 2 may be combined with Option 3—or, as mentioned above, a single year of on-the-job experience may be combined with Option 2 or Option 3. Proof of education and/or on-the-job experience should *only* be submitted once your full two-year requirement has been satisfied. Submit all documentation via scanned email attachment or fax.

Additional Course Considerations

Q: I’m hard-of-hearing or deaf. Would I still be able to take your AAPC-certified medical billing and coding courses?

Yes. All our on-demand virtual courses are closed captioned, making them accessible for students who are unable to hear audio instruction.

Q: I’m worried I can’t succeed at an online course. What happens if I have questions about assignments or specific course content?

We understand your concerns, and we’ve designed our courses to specifically address them. Here are some key points to keep in mind:

- Our instructors are AAPC-certified, and AAPC medical billing/coding programs currently have the highest pass rate in the industry.
- You can take advantage of periodic instructor office hours when you have questions or need clarification on course content.
- We help you learn how to mark your books, get answers to frequently missed exam questions, adopt expert time management tips, and more.
- Our interactive virtual lectures are specifically designed to keep you engaged and fully connected throughout the course duration.
- We help you get ready for your certification exam with practice exams that mimic the real-life test.

Q: Is it common these days for practicing clinicians to transition into the billing/coding arena?

Yes, this practice is steadily becoming much more commonplace. In recent years, health care professionals have increasingly sought out specialized training that allows them to shift into academia or the field of health care technology. [According to the Bureau of Labor and Statistics](#), the medical billing and coding arena in particular is expected to grow roughly 15% between now and 2024. This rewarding field attracts considerable interest, while providing abundant opportunities to support patient-centered care and advance health equity.

Q: Are OCHIN's AAPC-certified medical billing and coding courses a good entry path into the data analytics field?

Our medical billing and coding courses are an ideal way to enter the fast-growing field of medical billing and coding. Because our on-demand virtual courses are certified by the American Academy of Professional Coders (AAPC), they address everything other medical billing and coding institutions teach—and we *also* share specifics related to the unique needs of federally qualified health centers (FQHCs) and FQHC look-alikes. However, our program is *not* intended as a pathway into the field of data analytics. We are currently developing a separate OCHIN+ reporting program that may create specialized data science opportunities. Please check our ochin.plus website periodically for the latest updates.

Q: Are OCHIN's AAPC-certified medical billing and coding courses a good entry path to becoming an EHR Support Analyst (formerly Site Specialist)?

Our medical billing and coding program is *not* intended as an immediate path to becoming an EHR Support Analyst. That designation typically requires a bachelor's degree in computer science, information technology, or a similar field. Experience with general health care organization responsibilities and electronic health records (EHR) is also extremely beneficial for the EHR Support Analyst role.

Q: Do these medical billing and coding courses represent a good industry networking opportunity?

Potentially; however, please keep in mind that many non-industry professionals also take our courses as a way to transition into the field of health IT. We strongly discourage taking our courses as a primary vehicle for making new industry connections.
